# CHELMSFORD PUBLIC SCHOOLS FY 2016 BUDGET GUIDELINES & PROCEDURES

## **GUIDELINES**

1. The following departments will remain centralized:

Administration/System-wide Aff Special Education Te Curriculum, Instruction & Assessment Food Service (General & Revolving Funds)

Athletics (General & Revolving Funds)
Technology & Information

- 2. With the exception of the centralized departments, all budget accounts will be budgeted by SCHOOL. Salaries will be based upon existing contracts.
- 3. The following departments will remain self-supporting with no budget appropriations:
  - Community Education (including employee benefits)
- 4. The Principal will be responsible for constructing the non-salary budget for each school. Department Coordinators, in conjunction with the principal, will be responsible for constructing the budget for the academic programs.
