Social Emotional Needs Returning to Full In-Person Learning

- The Pandemic has impacted mental health, social emotional development & well being of students
- It is important to acknowledge & recognize the Pandemic has disproportionately impacted vulnerable populations
- The current rise in Mental Health needs is stressing
 community mental health resources & the healthcare system
 "Recent studies show the pandemic exacerbated an already
 growing crisis in youth mental health" (NPR January 7, 2022)

Youth Risk Behavior Data Overview

- Online
- The data breakdown: by gender and by grade level
- Risky behaviors (i.e., drinking alcohol, vaping, marijuana use) were overall significantly reduced from previous years:
 - Alcohol consumption in past 30 days (21.4% 2022; 31% 2020)
 - Binge Drinking (10.5% 2022; 16.8% 2020)
 - Marijuana, lifetime usage (17.6% 2022; 31.6% 2020)
 - Driving in a car with someone who has been drinking (9.6% 2022; 15.3% 2020)
 - Sexual Intercourse (19% 2022; 27.6% 2020)
 - Vaping, lifetime usage (17.6% 2022; 37.8% 2020)
- Mental Health concerns stagnant in some areas and have had a slight increase in other areas


Middle School Summary

- 91% of 6th, 7th, and 8th grade students took this survey for a total of 1,067 participants
- One of the questions asked about how students identify, which is important to note when looking at this data:
 - 41.5% (442) of students selected "female"
 - 53.1% (565) of students selected "male"
 - 0.3% (3) of students selected "female transgender" (0.1% 2020)
 - 0.9% (10) of students selected "male transgender" (0.6% 2020)
 - 2.2% (23) students selected "non-binary" (0.4% 2020)
 - 2.1% (22) students selected "other" (0.9% 2020)
- Therefore, when reading through the data; is important to keep in mind the "other" category is a representation of 22 students and the transgender/non-binary category is a representation of 36 students.

High School Summary

- 80% of 9th, 10th, 11th, and 12th grade students took this survey for a total of 1,072 participants
- One of the questions asked about how students identify, which is important to note when looking at this data:
 - 47.8% (510) of students selected "female"
 - 47.5% (507) of students selected "male"
 - 0.6% (6) of students selected "female transgender" (0.2% in 2020)
 - 0.7% (8) of students selected "male transgender" (0.9% in 2020)
 - 2.2% (24) students selected "non-binary" (1.5% in 2020)
 - 1.2% (13) students selected "other" (0.5% in 2020)


Therefore, when reading through the data; is important to keep in mind the "other" category is a representation of 13 students and the transgender/non-binary category is a representation of 38 students.





During the past 12 months, how many times did you hurt or injure yourself ON PURPOSE? (For example, by cutting, burning, or bruising yourself on purpose.)






During the past 12 months, have you SERIOUSLY thought about killing yourself?






During the past 12 months, did you ever seriously consider attempting suicide?



During the past 30 days, how often was your mental health not good? (Poor mental health includes stress, anxiety, and depression.)




During the past 12 months, did you ever feel so sad or hopeless almost every day for two weeks or more in a row that you stopped doing some usual activities?



During the past 12 months, did you make a plan about how you would attempt suicide?







RE: 2022 Student Testing Update

This spring, students in grades 3-8 and high school will participate in MCAS testing in ELA, mathematics, and science, technology, and engineering (STE). Last year, the Department of Elementary and Secondary Education (DESE) provided both a truncated version of MCAS testing for diagnostic purposes only with only one session in ELA and mathematics, and STE, as well as modified competency determination (CD) for the graduating classes of 2021, 2022, and 2023. This year, testing sessions will return to the original schedule of two session for each content area starting in March for all students in grades 3-8 and 10 (to include grade 9 students taking biology this year). Current seniors (class of 2022) were provided with a CD waiver due to the pandemic and its effect on teaching and learning, which allowed for students to meet their CD requirement by passing their current courses in ELA, mathematics, and STE. The current juniors (class of 2023) participated in the truncated version of MCAS last spring in ELA and mathematics to meet their CD requirement and continue to be covered under the testing waiver process for STE as their CD requirement. Any junior or senior students that fell under the CD waiver process and desired to take MCAS to qualify for the Adams Scholarship were tested this past November to be considered. Additionally, students taking content tests to qualify for the <u>Seal of Biliteracy</u>, will use the CD waiver process in 2022 and 2023 to meet their proficiency level in ELA.

ACCESS testing for our English language learners began this January and is anticipated to be completed prior to February vacation. All ACCESS testing must be completed by March 4, 2022.

Below is the testing windows for grades 3-8 and testing days for the high school in ELA, mathematics, and STE.
