RE: Update to 2023/24 School Year Calendar – Professional Development Days Change

On Tuesday, December 20, 2022, the School Committee voted on the 2023/24 school calendar. This calendar included the designated professional development days, for teachers to attend district workshops. When the professional development days were established for the 2023/24 school calendar, the 2024 election calendar was not available. Since McCarthy Middle School is one of the town's centralized voting buildings, professional development days are typically scheduled on election days to minimize access to the McCarthy building and to alleviate parking and traffic congestion that can potentially impact the functioning of the school day. After reviewing the established 2024 election calendar from the town clerk, we discovered that the March 2024 election day established for the Presidential Primary does not align to the scheduled professional development half-day for March in the 2023/24 school calendar.

After discussion with Dr. Lang and Dr. Parks, it was determined that we request of the Committee, a switch for the professional development half-day in March 2024, previously established in the 2023/24 school calendar, to be in alignment with the published 2024 Presidential Primary election day to minimize disruption to the McCarthy school day. The proposed change for the affected professional development half-day previously scheduled is as follows:

• Move Wednesday, March 6th to Tuesday, March 5th (Presidential Primary)
